Beatty ELC Points of Pride- Spring 2022

- Beatty provided holiday support to the families through three different events: the 2021 Mullick Challenge Holiday Shopping Event in which families received a \$50 Meijer gift card for every child in the household. They also received books, a box of cleaning supplies, and a gift card for a free meal, Kings of Christ Church in which six families received Thanksgiving and Christmas dinner as well as gifts for the entire family, and Bethany AME Church Wonderful Time of the Year Gift Card Giveaway where four families received \$250 gift cards to Walmart, Target, Meijer or Kroger to purchase food and gifts for the holiday.
- Washtenaw Promise provided funding for a <u>mentor program</u> at Beatty where college students joined the preschool students outside on a weekly basis to mentor and support the students. We loved having the mentors provide this one-one-one attention to our students! *(organized by Katie Watson, Behavioral Health)*
- Washtenaw Promise also supported a <u>Pen Pal program</u>, where our students were given the opportunity to have pen pals; they'd write letters back and forth all year, and recently we had a "Popsicles with Pen Pals" event where the children got to spend the afternoon playing outside and having popsicles with their pen pals. (organized by Katie Watson, Behavioral Health)
- Every Tuesday, students at Beatty ELC get to experience the <u>Bob-a-Loo program</u>, which is a program that allows students to learn about healthy habits and experiment with various gross-motor activities to enhance their learning. This program was funded for us by Washtenaw Promise. (*organized by Lakeya Jones, Associate Teacher*)
- In March, Beatty held a <u>March Is Reading Month event</u>, supported financially by Washtenaw Promise and in person by the mentors. The students got to play literacy games, create literacy-related crafts, and even got to experience some of the tasty treats that the Very Hungry Caterpillar got to eat. (*organized by Katie Watson, Behavioral Health*)
- <u>YCS Farm to School Collaboration- Greenhouse Planting with Jen Sopoci</u> In mid-April, Jen visited Beatty to help children plant various seeds (beans, corn, etc.) for the on-site greenhouse. Beginning in mid-May Jen will spend time weekly with every classroom tending to the seeds and learning about the gardening process.
- Beatty is involved in healthy eating for the students. In late April, TC Collins came to Beatty to teach the students about various potatoes and helped every student plant a potato to take home. And each month, families are given a large box of healthy fruits and vegetables to take home from Food Gatherers. (organized by Shamya Butler, FSS)

Action: A. Audio Expansion Project - Solomon Zheng

The audio project shifts our audio equipment from individual standalone units to one single cohesive sound system that is networked and unified together. This allows for building and district wide control of the entire system. In order to connect these units new cabling must be run for the buildings. Instead of just power and audio cables, each classroom and hallway speaker needs new network cabling in order to communicate with the local building server and the district wide server.

The original proposal from Sequoia Technologies only covered a single network connection to the room. We had to work with the original vendor to update their quote to bring in a second connection per classroom per building to accommodate all of the system's needs.

12. DISCUSSION

Discussion: A. Board of Education Subcommittee Reports

Trustee Goodrich: Trustee Townsend, Dr. Zachery-Ross, and I attended the April 21st WISD Annual budget review. I really appreciate the board passing the resolution in support of the budget.

Trustee Schindler: The SEAB met.

Trustee Gainsley: The YCSF board met in April and discussed scholarships.

13. BOARD/SUPERINTENDENT COMMENTS

Vice President Lee: A concern about the voting in schools while the schools were in session.

Dr. Zachery-Ross: The in-person turnout was very low. The access to the building is separate for the people voting and the students. We have no school in November during the voting because there is a larger turnout. We won school safety grant to keep students safe in classroom for \$250,000. We were one on nine to receive the largest grant. It will be used to improve our PA Systems throughout the schools and for trauma supplies. We won the Tech and Learning award for what is happening in the schools for social, emotional wellness for students, staff, families, community. Lauren Fardig-Diop won the La Fontaine Teacher of the Year award for the whole Washtenaw County. She is getting a free two-year lease on the car of her choice. Thank you to all the board members who showed up to support her and the district.

Trustee Gainsley: Support giving all staff the \$2000.

Dr. Zachery-Ross: We did all our negotiations in good faith, putting an extra \$2000 in the contract for the next three years. We need to keep our budget in line, people are watching. Buses are costing more. We hope that the staff can see the actual results of increasing pay, etc. There is Covid pay now. The SEEK grant is only for instructional staff and administrators. This Covid pay will make a big difference in our support staff in particular. We felt it was important to give it to all staff not just instructional and administrators. They have worked their tails off.

Trustee Townsend: We started at \$1750. The amount that we are giving is \$2000.

Dr. Zachery-Ross: The \$2000 is going to every person employed by the district.

Dr. Hawkins: It is the will of the board that the \$2000 is acceptable and we will let the administration take it from here.

Dr. Zachery-Ross: We wanted to make sure we brought this to the board. The rational to have one payment in May and one in June was to make sure the staff took home as much as possible.

Dr. Zachery-Ross: Thank you for all the support at ACCE this morning to recognize Lauren Fardig-Diop for her accomplishment of the La Fontaine Teacher of the Year. Lifting up the Seniors Honors program. We are hoping to do more of these events with the public in attendance. The support through the YCS Foundation, through Kiwanis will be recognizing some of our students on May 16th. We have WIHI graduation on May 26th. We will be back at the EMU Convocation Center on June 8th for YCHS/ACCE graduation where the public can join us in that large venue. The mask survey ended today and I will be bringing the recommendations to the board on May 17th. We had five Washtenaw students names "Young Citizen of the Year" and we are very proud of that. We had two students from WIHI, Harshede Arnon and Kaden Hawkins. We are proud of all of our young people.

Dr. Hawkins: May 17th we don't have a regular board meeting that week. We will have a board workshop on that Tuesday with Dr. Dorinda Carter-Andrews. Congratulations all around and we appreciate all the hard work.
