Vice President Lee: There was a pre-school meeting on October 18th and there were three in attendance. There will be another meeting soon and Ms. Skinner will inform me of that meeting. The YCS Foundation wanted me to invite all the board members to an event on Friday, October 29th 5:30 p.m. at the Ypsilanti Commerce parking lot with cider and donuts and everyone is invited. I am personally invited everyone on behalf of Kathy Beal to this fundraiser.

Trustee Gainsley: The entire board was at the YCHS football game on Friday and I just wanted to say thank you to the city of Ypsilanti for their generous contribution and to Councilman Anthony Morgan in particular who spearheaded the effort to have the city support our athletic department.

Trustee Fields: I teach free adult classes open to anyone in the community on Wednesday nights from 6:00 - 8:00 p.m. teaching computer skills, basic computer, how to get on social media, internet, and it is all free. I also teach seniors on Saturdays from 10:00 a.m. - 12:00 p.m.

Our bus drivers are out there and they get the brunt of it because of the ones who don't show up but for the ones who do I just want them to know how much they are appreciated. They have picked up the slack and done extra routes. There are 17 interviews set up this week for bus drivers and monitors. Thank you to Solomon Zheng, Trustee Goodrich and Trustee Gainsley for working on the transportation app. There are still glitches but we are hoping to roll it out this week. There are simple instructions for the parents to you and you will be able to follow and see where the bus is and see when you student gets on and off the bus. There is a back order for the swipe cards. And the whole system had to be upgraded and he has done a wonderful job picking up the pieces. We know it is important. We believe that these strategies will help in the transportation department. Safety first is the focus. If drivers or monitors aren't feeling well, they cannot come to work because we want to keep everyone safe.

Next it is parent/teacher conference week. If you are doing it by zoom, please remember your time. If you are in person, you need to wear a mask in the building.

November 2nd - no school. There will be PD trainings all day. Thank you for the support of our staff.

Starting next week the HRAs (health resource advocates), will be in the district. They have been hired by the WISD and we will have one full time and one part time nurse. They will be the ones doing the contact tracing. They are medical people. They have the background and they are working directly with the health department.

Dr. Hawkins: Appreciate the flexibility and grace of our families. We never want to inconvenience families and I know that the district is doing everything they can to right the ship, to have the proper staffing to make sure kids are in school on time.
