9. REQUEST FOR CLOSED SESSION: Section 8(h) OMA, Attorney-Client Privilege

Action: A. Attorney-Client Session

In accordance with Michigan's Open Meetings Act (OMA), enacted in 1976 as Public Act 267, all closed meetings must be called by a motion at a public meeting of the Board of Education followed by a roll call vote. The Board of Education needs to meet in closed session under Section 8(h) of the Open Meetings Act, Attorney-Client Privilege.

In order for the board to go into closed session, 2/3 of the board must be present. That would require five trustees to be at the meeting. There are only four. As a result, the board can not go into closed session. After consulting the Open Meetings Act with the attorney from Thrun, Kirk Herald, Dr. Zachery-Ross explained what could happen next.

Dr. Zachery-Ross: The attorney can explain how we could proceed with the action item.

The board agreed to proceed this way.

Attorney Herald: Can't go into closed session but could discuss what we would have discussed in closed session in open session, or you could just go to the action item to allow the superintendent or her designee to negotiate on behalf of the school district.

Trustee Townsend: This gives the superintendent the ability to start the process but in the end the board would see the final result and vote on it.

Attorney Herald: The board could do that or just give the superintendent the ability to handle the whole thing.

Trustee Gainsley: 3 parcels question

Attorney Herald: Part of the negotiation, waiting on the county

Trustee Townsend: This give the superintendent the ability to negotiate, modify, and execute a purchase and we just need to decide if the board would have a final vote or not.

Attorney Herald: Yes.

Trustee Gainsley: My understanding was we were deciding on giving the superintendent the authority to negotiate and complete the agreement and I feel comfortable moving forward with that tonight.

Trustee Fields: Closing costs?
Trustee Gainsley: Number 8.

Trustee Townsend: So we just need to add language to the motion that will include final board approval?

Attorney Herald: The board has two options: you can authorize the superintendent to negotiate and finalize the agreement or you can have the superintendent negotiate and finalize an agreement that has to come back to the board for final approval.

Dr. Zachery-Ross: If you go with the latter, we would have to have another board meeting.

Trustee Goodrich: I am comfortable with the motion before us to have the superintendent negotiate, modify, and execute the agreement. It is in line with our goals.
