Trustee Fields: I agree. We don't need to add another store that sells hard liquor in the area.

Trustee Townsend: I agree with everyone. It is in excess.

Trustee Goodrich: We need to explain how it would have an adverse effect on the school.

Dr. Hawkins: I agree with everything. We also don't have enough things in the area to promote a healthy lifestyle. We need things to promote a healthy lifestyle, like a grocery store. Why add another place that sells hard liquor?

Trustee Goodrich: This license would just increase access to our students.

Dr. Hawkins: We promote healthy communities, and this doesn't align with our values.
