YCS HOMELESS REPORT 2021

MARQUAN JACKSON, HOMELESS LIAISON APRIL 2021

CONTEXT-HOUSING AFFORDABILITY

- The one thing that all people experiencing housing instability have in common is the lack of affordable housing. Washtenaw County has the most expensive <u>housing market</u> in the state of Michigan. In Washtenaw County, the standard cost (Fair Market Rent or FMR) of a two-bedroom apartment is \$1,025/month. According to the most recent <u>National Low-Income Housing Coalition's report</u>, in order to be able to afford that, a person would need to be earning at least \$19.71/hour. If working at minimum wage (\$8.90/hour), a person would have to work approximately 89 hours per <u>week</u> (that's over 2 full-time jobs) to afford a two-bedroom apartment.
- In Michigan, 62 percent of jobs pay less than \$20 per hour, with two-thirds of those paying less than \$15 per hour.



THE MCKINNEY-VENTO ACT

• Homeless children and youth often have problems enrolling and participating in school. As a result, Congress passed the McKinney-Vento Homeless Assistance Act in 1987.

This law gives homeless children and youth the right to:

- Remain in the same school even if they move;
- Enroll in a new school without typically required records such as proof of residency, immunizations, school records, or other papers;
- Get transportation to school;
- Get all the school services they need; and
- Challenge decisions made by schools and districts.



YCS POINT IN TIME DATA MARCH 2021

- # of homeless students reported via 2020-2021 EPHY referral: 98
- % of families, identified as homeless the last 2 school years: 28%



- YCS Schools with the largest number of displaced students: Ford Early Learning Center and Holmes Elementary
- Numbers are down significantly, low numbers could be attributed to Virtual Learning and CDC Eviction Moratorium.
- During the 2020-2021 year as of 4/1/21 YCS has spent less than \$1,000 on transportation for homeless youth.
- Currently YCS is transporting 2 students daily via cab
- YCS is providing gas reimbursement to **3** families. (Self Transportation)

CDC Eviction Moratorium



The Biden administration <u>announced</u> last week an extension of the <u>federal eviction moratorium</u> through June 30, 2021, and greater enforcement of the moratorium's protections – two measures that will help keep millions of renters stably housed during the pandemic and prevent further spread of and deaths from COVID-19.

-This prevents families from being evicted for non payment of rent.

The extended moratorium and its enforcement are essential to help ten million families remain in their homes as states and local communities work to distribute <u>emergency rental assistance</u> to address arrears and prevent evictions.

RESILIEI CENTER

Every child should have access to basic needs so that they can focus on their education. At Ypsilanti Community Schools (YCS), more than 80% of our students receive free or reduced lunch. The idea behind the Resiliency Center is to be a resource for some of our student population and their families who struggle to meet their basic needs such as access to clothing, school supplies, personal hygiene products and food. As a district, if we have creates a system that allows the community and its partners to have collective impact and provide access to basic needs, YCS students and families can keep their focus on education. Creating such a system will allow the district to continue to stand in the gap for our families while also SAVING LIVES!

68 of the Households report being unemployed/laid off.






Assumptions behind the Revenue Projections

ESSER Funds Allocation 90%

Appropriates **\$650 million through the Title IA formula** as required by federal law.

- This is roughly 43.6% of the funds out of 90%.
- Since Governor Whitmer vetoed HB 4049 \$840 million remains unappropriated.
 - HB 4049 amends the public health code, prohibiting the state from limiting in-person instruction or athletics.



Financial Implications for YCS

- Ypsilanti Community Schools Estimated Total Allocation -\$9,424,164
 - ESSER II: \$2,502 per pupil approx
 - Receives \$4,108,936 \$1,091 per pupil
 - Unappropriated \$1,411 per pupil
 - SAF Equalization Payment
 - Does not receive equalization payment since ESSER II funding is over \$450 per pupil for YCS.
 - No in-person instruction requirement.

ESSER II Funds- \$4.1M

Section 11r(2) Releases 43.6% of ESSER-II Formula

- Spending Plan, aligned with 15 ESSER-II allowable grant use areas, must be submitted by district by April 15 (April 23 in statute) for ALL that received ESSER-II formula funds.
- Submission is in GEMS/MARS electronic system ONLY for 43.6%
- NOTE: MDE cannot approve any applications for Grant Funds Available until the approval from legislative/executive action.





FTE Staffing Projections by Building 2021-22



What is the purpose of the FTE Staffing Projections?

- Annually Full Time Equivalent (FTE's) are calculated to determine a base staff allocation for the next school year
- Building Administrators present rationale for their building needs
- Allows for staffing adjustments prior to the finalized budget because it informs budget implications



How are the FTE's Calculated?

Data is gathered from multiple sources:

- Student count from PowerSchool
- Input from building administrators
- FTE's from the previous school year
- Sub group data allows the district to allocated staffing for Title I, Title IV, 31a, ELL and other categoricals

What is considered for Final Determination?

- Student needs are the first consideration
- Individualized Education Plans (IEP) requirements
- Teacher Certification required especially for secondary levels where staff must be certified by subject i.e., Math, Science, Social Studies and English
- Staff to Student Ratio per the Collective Bargaining Agreement
- Staff to Student Ratio based on the COVID-19 recommendations for smaller class size to ensure safety

Dr. Hawkins read the public comments:

1. Lisa Watkins, Associate Teacher Ford Early Learning Center and President of the Educational Support Professionals of YCS, I was recognized by the Superintendent and Sue McCarty I would like to extend my heartfelt appreciation for their recognition.

2. Debra Stevens, Perry ELC, It has been exciting to welcome back our youngest learners over the past 3 weeks but their return has elevated concerns as COVID cases in Michigan continue to rise. Currently, Michigan has the 4th fastest growth rate of COVID cases in the U.S. and ranks 2nd for the number of COVID variants identified.

Many staff members have expressed concern about the communication regarding cases in the district. Surrounding districts inform ALL staff and families immediately when positive cases of COVID are identified in the district. YCS does not appear to have such a "fine tuned" method since much of the information that staff receives is unfortunately through the grapevine. When positive cases are discovered at different buildings, only staff in those buildings seem to be notified. This causes a lot of stress and possibly misinformation being shared. There is also is a lot of confusion about what the protocols are when staff or students are identified as having COVID. Who is supposed to quarantine and for how long? Is there a detailed method for contact tracing? Can teachers teach remotely if they have to quarantine?

When a positive case is discovered in a building, please consider sending out an email similar to the one that is sent IMMEDIATELY each time a case is reported by several districts in Washtenaw County. The email does not identify whether the case involves a staff or student so it maintains privacy but shares all of the necessary information.

Subject: Notification of a Positive Covid-19 Cases at (NAME OF SCHOOL)

Anonymous, Staff, I've had the pleasure of helping out YCS families this year and have observed a significant concern with the communication with our families. Today alone, two families contacted staff indicating frustrations, because YCS had not submitted the PEBT information accordingly (and had to do their own foot work to try and identify who to talk to to assure they're supported with this gift from the stare) and has now potentially delayed their monetary funds coming from the state of Michigan. It has been very hard to connect families to resources during the pandemic and understanding situations like this and who to contact, has been very frustrating. In fact, many of our families never received the first round of funds from the PEBT distribution and now may not even qualify for this round.

This along with changes in learning platforms, positive cases, transportation restrictions, etc. has not been communicated well with our families, as not everyone accesses their emails. How can we as a district work to communicate important information to our families more accordingly?

Superintendent Zachery-Ross: Huge misconception - the state takes our data straight from the students who are registered and then Child Nutrition Services takes care of the cards, we at the district level don't have any contact. The only issue that we can try to solve is if the student's address is wrong. IF people haven't gotten the money, there is a number on the website to call.

12. OTHER

Superintendent Zachery-Ross: Thank the parents for being flexible because Perry had to close because of a shortage in food service. The need is greater for food service, transportation, custodial as more students come back to make sure we are following the CDC guidelines. We haven't had cases. It's about quarantines. The letter that was shared earlier is part of our letter but we have to be careful (guidance from our attorneys) about HIPAA because some of our buildings are so small that people may be able to figure out who is being referred to in an email. We are trying to be cautious and open while we navigate through a pandemic. We have been updating our dashboard whenever we have had any cases. But people still have anxiety and are taking off work. If we are short on staff, we will look to make sure that the staff and students are safe, with enough custodians to clean, drivers and monitors on the busses and enough food service to deliver the food which requires a lot more staff than when the students came to the cafeteria. Spring break is next week so please be safe for you and for the students.

13. BOARD/SUPERINTENDENT COMMENTS

Vice President Lee: YCS Foundation, March 9th - mini-grants, 6 teachers didn't get the application, concerned for next year letting people know before the deadline runs out. Superintendent Zachery-Ross: Jerilyn was at the building meeting and reminded everyone and she included it in the newsletter, some people don't read their emails and that is how we communicate with staff, especially during a pandemic and they are remote, she did a great job letting them know that it was closing. It was everywhere, on the district website, in multiple places. Thank you to Jerilyn. The info even went to the board members. Dr. Hawkins: It did. The last one we got was on Feb. 25th, she saw a few communications about the mini-grants come through email. Vice President Lee: Bill was upset that 6 teachers missed the opportunity to get a mini-grant for lack of communication but it doesn't look like there was a lack of communication.

Trustee Schindler: Impressed with all the late night texts last night and the calm demeanor that the superintendent and team brought to the very difficult problem-solving situation. Thank you for the strong leadership. Still in the weeds of this pandemic. SEAB committee wants to get on the agenda in May for a presentation on their new recommendations for some updated guidelines on some sex ed curriculum. Very hardworking and inclusive group.

Trustee Fields: Suggestion for Vice President Lee to let people know to check their spam folders.

President Hawkins: Meeting in April, space on the agenda for subcommittee meetings for any reports that anyone would like to share. Policy Committee met in February to talk about bi-literacy. Impressed with the NACIIP at Night, a great evening. We are still under the DHHS Emergency Order and PA 254 of 2020. The order might be changing by the end of the month, she will keep everyone informed if things change with the format of our meeting. She saw some information about the board of commissioners for Washtenaw County met to approve that meetings can be held for public bodies/elected officials through December 31. She will confirm and let everyone know through email.

Superintendent Zachery-Ross: this Friday is half day/records day for students which leads them into spring break from March 29 through April 6, all YCS students. We wish them a safe, relaxing time, to take care of their social/emotional part of their learning, this is their opportunity, try to have less screen time and spend time cohorting with your family. March 22nd is the start of YCS spring sports and the new guidelines from the governor that all the students will receive antigen testing. We are sharing these guidelines with the parents. Thank you for the grace. We will make it through this year stronger together. When you are making decisions during spring break be safe because it is important for our students and for the whole community. This past Saturday we were able to host, along with the Washtenaw County Health Department, a vaccination clinic that went very smoothly. Ruth from the health department was grateful and we thank our custodial staff who was out there working with them. We are planning on several others in the upcoming days and weeks especially as we know the requirements are going down from less than 50 year olds all the way to the 16 year olds and we want to make this easily accessible to all of those in our community.
