Superintendent Alena Zachery-Ross shared a tribute to retirees, followed by presenting a retirement award to those present.

Schneider Electric Update: WIHI Government Teacher Ashley Fox introduced two students who led a PowerPoint presentation, "Efficiency and Sustainability at School". WIHI has a committee of 15 students and many more who are passionate about efficiency and sustainability. Fox thanked those who inspire students with these ideas. Presentation included: 1) Phase 1 | LED Lighting and New Boiler; 2) What is Performance Contracting?; 3) Building Assessment; 4) Phase 2: Going Further ..., and; 5) What Could Phase 2 Look Like?

Schneider Electric recently installed LED lighting at WIHI. The new lighting is more efficient and saves money. Monies saved could pay for an investment of a boiler. Students learned about performance contracting in government class.

Randy Trent, Director of Operations introduced Scott Mason from Schneider Electric. Trent communicated the total project cost is approximately \$3.7 million and he spoke of District savings. Currently, we are about 40% complete with the project. Each classroom can adjust the level of lighting; studies show students can achieve more at a specific level of lighting.

Notification of Emergency Repair | YCHS Chiller: Randy Trent, Director of Operations informed the Board of an "emergency chiller repair" at Ypsilanti Community High School. Purchase orders totaled in excess of the state purchasing limit of \$24,459. Trent also stated we have on-going boiler issues. Trustee Schindler acknowledged being proactive and following Board policy.

RESOLUTION AUTHORIZING ISSUANCE OF NOTES IN ANTICIPATION OF STATE SCHOOL AID (AUGUST 2019 BORROWING THROUGH THE MICHIGAN FINANCE AUTHORITY)

Ypsilanti Community Schools, Washtensw County, Michigan (the "Issuor" or "School District")

A regular meeting of the board of aducation of the Issuer (the "Board") was held in the Professional Development Room of the Administration Building, within the boundaries of the Issuer, on the 24th day of June, 2019, at 6:30 o'clock in the p.m.

The meeting was called to order by Dr. Celeste Hawkins, President,

The following preamble and resolution were offered by Member Maria Sheler-Edwards and supported by Member Brenda Meadows:

WHEREAS, under the terms of Section 1225 of Act 431, Public Acts of Michigan, 1976, as amended (the "Act"), the School District is authorized to borrow money for school operations and issue its notes therefor, no no errow reserves, pledging in the payment thereof moneys to be received by it pursuant to the State School Aid Act of 1979, Act 94, Public Acts of Michigan, 1979, as amended (the "State Aid Act"), which notes shall be the full faith and credit obligation of the School District; and

VHEREAS, the estimated amount of the state school ald appropriations attocated or to be allocated to the School District for the fiscal year ending June 30, 2020 and expected to be needly of the School District from October 2019 (flough August 2020, inclusive (the "2019/2020 State Aid" or the "Pledged State Aid"), is shown in paragraph 1 of Eshibit A; and

WHEREAS, the School District has the need to borrow the sum of not to exceed the amount shown in paragraph 2 of Exhibit A to pay operating expenses for the fixeal year ending June 30, 2020, which aniount is estimated to be not more than 70% of the difference between the total state school aid funds apportioned or to be apportioned to the School District for the 2019/2020 State Aid and that portion of the 2019/2020 State Aid already received or pledged; and

WHEREAS, the School Obstrict plans to issue or has issued notes, bonds or other obligations subject to Section 148 of the Internal Revenue Code of 1986, as amended (the "Code"), relating to arbituage and the rebate thereof, including but not ilmited to federally tax-exempt and/or tax-advantaged bonds and other obligations, not including this borrowing, during calendar year 2019 in the aggregate principal amount shown in paragraph 3 of Exhibit A; and

WHEREAS, the School District determines that it is in its best interest to borrow the sum of not to exceed the amount shown in paragraph 2 of Exhibit A and issue general obligation notes in one

Authority shall intercept 100% of the Pledged State Aid to be distributed to the School District and apply the intercepted amount on the following priority basis: (1) the fundamental shortfall; (1) the current month's Installment; and (1) any amounts remaining to be immediately distributed to the School District. The Intercept process set for the above shall continue each month following the Installment Shortfall until sufficient (India and apposited with the Depository to pay the rotal principal of and interest on the Notes. Unless expressly authorized by the Authority, the maximum amount of each Installment will not exceed 50% of the amount of Pledged State Aid due to the School District in any set-seide month.

- B. If the School Discret has falled to deposit all or a portion of att Installment by the last business day of the month of the Installment, the Depository Is authorized and discred to give written notice to the Authority, the State Treasurer and the School District on the first business day following the last business day of the month of the failure to deposit all or a portion of the Installment. Upon receipt of such written notice from the Depository, the Authority shall promptly notify the School District that it will immediately commence to intercept 100% of the Piedged State Ald.
- C. If on the date of the final installment as specified in Schedule I to the Piechaie Contract, the funds with the Depository are insufficient to pay the principal of and interest on the Notes when due, the School District, pursuant to Section 17a(3) of the State Aid Act to the extent necessary to meet the payment obligation, assigns to the Authority and authorizes and directs the State Tressures to advance all or part of any state school aid payment which is dedicated for distribution or for which the appropriation authorizing the payment has been made.
- D. Any Authorized Officer la further authorized to agree, if required by the Authority, to assign to the Authority and authorize and direct the State Treasurer to Intercept all or part of any state school aid payment which is dedicated for distribution or for which the appropriation authorizing the state school aid payment has been made pursuant to Section 17(a)(3) of the State Aid Act.
- E. Any Authorized Officer is further authorized to determine that each installment is a partial mandatory redemption of a particular series of the Notes and that the last installment is the maturity date of that series of the Notes, and such determination shall be conclusively ovidenced by the Purchase Contract described below.
- P. The School District authorizes and consents to the Authority entering into an investment agreement with a financial littitution for the investment of funds deposited with the Depository on behalf of the Authority and the School District.
- 5. Any Authorized Officer is authorized to sell all or a portion of the Notes to the Authority without an Iosalament payment schedule (the "No Set-Acide Notes") pursuant to the pravisions of this resolution. In that event: (A) any Authorized Officer is further authorized to agree, if required by the Authority, to assign to the Authority and authorize and direct the State Treaturer to intercept or advance all or part of any state school aid payment which is dedicated for digribution or Porwhich the appropriation authorizing the state school aid payment which is dedicated for digribution or Porwhich the appropriation authorizing the state school aid payment has been made pursuant to Section 17a(3) of the State Aid Act; (B) the School District acknowledges that payment of this principal of and laterest on certain of the No Set-Aside Notes may be sourced by a direct-pay letter of reddit issued for the account of the Authority and the School District on one of the Purchase Continut or the No Set-Aside Notes if the principal of and Interest on the No Set-Aside Notes if the principal of and Interest on the No Set-Aside Notes shall have been paid in full when due to the

NOW, THEREFORE, BE IT RESOLVED THAT:

- I. The School District, pursuant to Section 1225 of the Act, shall issue its Notes in one or more series in order to borrow for the above purpose a sum not to exceed the amount shown in paragraph 2 of Exhibit A, the final amount and aeries designation to be determined by an officer designated in paragraph 4 of Exhibit A, or a designee who shall be a member of the administrative staff or board of education of the School District (each an "Authorized Officer"), prior to the sale of the Notes, or such portion thereof as the Mitehlgan Department of Treasury (the "Treasury") may approve. If prior approval is receivany, and issue the Notes of the School District therefor in anticipation of the distribution of the Pledged State Aid.
- 2. The Notes shall be issued in one or more series, bear interest at the rate or rates determined on the sale thereof; which shall not expected the mealmum rate permitted by law at the time of sate, be dated as set forth in paragraph 5 of Bahibit A, ones of the date of delivery, and be due and payable on the date shown in paragraph 5 of Eshibit A. The Notes shall be payable in lawful money of the United States of America at a bank or trust company qualified to ect as paying agent in the State of Michigan, as shall be designated by the Authority. The Notes shall be in denominations to be determined by an Authorized Officer piter to the sale of the Notes. The Notes shall be subject to redemption prior to maturity as specified in the Purchase Contract described below.
- 3. The School District hereby appropriates a sufficient amount of the Pledged State Aid to repay the principal of and interest on the Notes. In addition, the full faith and credit of the School District is hereby interocably pledged for payment of the principal of and interest on the Notes and, to case of the insufficiency of the Pledged State Aid, the School District shall pay the Notes from any funds legally available therefor, and, if necessary, lovy sufficient taxes on all taxable property in the School District for the payment thereof, subject to applicable constitutional and statutory tax rate limitations.
- 4. In the event any Authorized Officer determines that it is in the best interest of the School District to choose to pay all or a portion of the principal of and interest on the Notes with set-aside installments:
 - A. The foregoing officials are hereby authorized to oxecute and deliver a temporary Note or Notes and exchange, when available, final printed Notes therefor at the request of the Authority.
- 7. Unless the Notes are issued as federally taxable, the School District hereby coverants for the benefit of all holders of the Notes to comply with all requirements of the Code that must be satisfied subsequent to the issuance of the Notes invote; that the interest hereon be or constitue to be exclused from gross income for federal income teation purposes, including, but not limited to, requirements relating to the rebate of arbitrage earnings, if applicable, and the expenditure and investment of Note proceeds and moneys deemed to be Note proceeds.
- 8. If newessary, any Authorized Officer is hereby authorized to make application to Treasury for end on behalf of the School District for an order approving the Issuance of the Notes and to pay any applicable fee therefor, or a posit-issuance filing fee, as a pulpitable.
- 9. The President, Vice President, Secretary, Treasurer, Superintendent, individual acting in the capacity of the school business official, or dealgace and say Authorized Officer are further authorized to execute any documents or certificates necessary to complete the transaction including, but not British as a president prelating to faderal or state socialities laws, tules or regulations.
