Recommendation Process

- Students placed on probation; families receive notification after 2nd marking period or 1st trimester (@conference and by mail)
- After 3rd marking period or 2nd trimester a Student List is compiled of students still on probation
- Committee: (Principal, Assistant Principal, Home Liaison, Community Liaison, Counselor, Dean of Students, Restorative Coach, parent/guardian) convenes to review each student's profile to determine fit for ACCE MS program
- Before year's end, student recommendations from YCMS and elementary principals; families notified
- Interview between committee and student (family)

GPS for District Fleets

Almost anyone working in district transportation operations has participated in a debate about the value of adding Global Positioning System (GPS) tracking to their yellow fleet. GPS offers the potential to increase efficiency and improve the collection of useful data, but it also raises a number of questions for those who aren't familiar with the technology, or who have only experienced the use of GPS hardware with limited functionality.

The demand for districts to collect and present operations data can be overwhelming, and this demand is only growing with time. The right GPS hardware can collect astounding amounts of data from an active fleet, such as real-time engine ignition, speed, location, confirmation of correct railroad crossings, and G-forces exerted on a vehicle as it accelerates, brakes and turns. A full-functionality GPS can even collect engine diagnostic codes and record information about accident-level events. Combined with software that can mine this data, a district fleet can implement changes to improve fuel efficiency, ensure the security of students and drivers, and create significant savings in operations costs.

The GO6™ GPS hardware from Geotab® combined with Tyler Telematic GPS™ and Onscreen® software from Tyler Technologies is the full-functionality GPS system which can provide these benefits to districts across the country. The GO6 GPS goes beyond basic bus tracking with its data collection capabilities,



and represents a significant leap forward in ease of both use and installation.

Standard GPS Functions

The GO6 GPS is capable of collecting the information district transportation coordinators have come to expect from fleet management hardware.

Tracking speed and location

With data collected from the GO6 GPS, fleet managers can instantly pinpoint the location of any vehicle. They can track speed in real time, and receive alerts for speed above posted speed limits. Also, fleet operators can access and report on data about on-time arrival and on-time departure from user-defined sites visited during the day.

Engine diagnostics



With the Input-Output-Expander (IOX) a plug-in component that expands the GO6 device, fleet managers can add on RFID technology, satellite tracking, and Garmin navigation and messaging, along with a series of other sensors and controls including Inputs/Outputs when not available from onboard controllers. The IOXs can be connected together (piggy-backed), and all can be used at the same time. This breakthrough technology allows for unprecedented levels of simultaneous data collection.





Intuitive firmware

The GO6 GPS is built upon firmware which intelligently manages uploads of onboard data, with the capability to learn and improve with time. For example, the GO6 GPS recognizes when the vehicle it is tracking is traveling in a straight line with little or no changes in speed or operation. In these cases, the GPS can intuitively decide to change the interval at which data is reported to more than a minute. If the bus is changing direction, speed, or otherwise indicating that an event is occurring, the GPS may decide to report data several times per second. This is all dependent on the value of the data.

This firmware is over-the-air upgradable: the GO6 device periodically contacts the server for any scheduled updates, and downloads them automatically. If the engine is already running, the GO6 GPS can still download its scheduled firmware while driving.

Accident Detection and Notification

If a serious accident is detected, transportation directors receive an automatic email or desktop alert along with the 72 seconds of data collected prior to the accident. The GO6 GPS additionally caches 102 minutes of pre-accident data. It can also uniquely detect vehicle-in-reverse collisions and alert managers to unscheduled reverse driving.

The data collected and reported by the GO6 GPS allows transportation managers to quickly respond to the requests from insurance companies or other investigative parties. A clear understanding of the causes of an accident is also invaluable to administrators when answering the concerns of parents/guardians or passengers.

Addressing Driver Concerns

The GO6 GPS also provides intelligent driver behavior tracking and can actively improve driver performance. Safe driving policies for speed and idle times, are encouraged by an audible alert which is played when activated by behavior triggers. This improves safe driving practices, as drivers take corrective actions when needed. Recording VIN, Odometer, and seatbelt use also helps managers audit vehicle use and identify safe and risky driving habits.

While many operators know how useful this kind of tracking can be when it comes to improving fleet safety and efficiency, many drivers are understandably nervous by the idea of a "Big Brother" machine tracking their performance.


But the highly-detailed data collected by the GO6 GPS can really be used to *protect* drivers.

Often, complaints about drivers or driver accounts of accidents can be difficult to prove, sometimes deteriorating into cases of "he said she said." How can transportation managers protect their drivers, while still appropriately responding to the concerns of students and parents?

What does an accident look like to witnesses?

The GO6 GPS saw the bus traveling without issue at 27 MPH, experiencing 0 G-forces. As the bus started down over the slope of a slight ditch the GPS logged negative G-forces. As the bus hit the tree, the GPS logged a -9.1 G-force event, and almost instantly afterwards a +8.5 G-force event as the bus settled back from the tree. All of this data was collected in less than one second of time.



At a school district that uses GPS, these complaints can be addressed with facts. With data collected by the GO6 GPS, complaints of harsh braking, excessive speeding, late or early arrival, or missed turns can be addressed immediately, and the data very often supports the driver's account of what happened in an accident. Often, the problem is only in the perception of events, and the driver is not at fault. Knowing this for a fact can protect the driver's job, and save a district the time and money that would be spent dealing with liabilities and litigation.

More than a Positioning System

While GPS has been around for nearly twenty years, it remains a relatively new phenomenon within the school transportation industry. A GPS industry expert found that, "GPS-based solutions can offer a lot toward the improvement of daily operations and future planning. The advantages will vary from district to district. Tracking vehicles can generate a lot of data, and small districts may find the information provided a bit overwhelming, but if a transportation department has people dedicated to future planning, the information extracted can be of great assistance in the development of effective and efficient route plans. This can translate into better service and a more cost-effective system. For smaller fleets, immediate advantages will come from being able to answer daily inquiries about the operation: 'Where was the bus last Tuesday at 2 p.m.?' and 'How fast was the bus going yesterday afternoon on Elm St.?'"

Understanding the advantages of GPS can be a daunting task. A basic GPS system does the simple—but also technologically remarkable—task of pinpointing the location of an object anywhere it goes in the world. But the real value of GPS is in the other technologies such as mapping, routing, tracking and accelerometer hardware that, when overlaid on GPS data, deliver data which can be used to improve efficiency and asset management. The GO6 GPS, combined with Tyler Technologies software, represents the most advanced district fleet tracking solution available to school officials today. - 4. John Dingell Jr.'s Father, the late John David Dingell Sr., proceeded him in service as a member of the House from March 1933 to September 1955. John Jr.'s wife, Debbie Dingell, succeeded him in January 2015 and continues to serve. Michiganders have entrusted John Sr., John Jr. and Debbie Dingell together to serve as their representative in Congress for the past 86 years; and,
- 5. John Dingell Jr. was elected to the 84th Congress, by special election, to fill the vacancy caused by the death of his father, United States Representative John D. Dingell Sr. John Jr.'s service was valued by his constituents, who reelected him to 29 succeeding Congresses (December 13, 1955 January 3, 2015); and,
- 6. John Dingell Jr. holds the record for the longest-serving member of Congress, representing Southeastern Michigan for more than 59 years; but it is not by this record that he will be remembered. He will be remembered for his accomplishments and achievements for the nation and its people; and,
- 7. Ypsilanti Community Schools expresses condolences to his wife, Debbie Dingell, who now represents his constituency in Congress and carries forward his legacy and work. To the family of John David Dingell Jr., we share in your sorrow.
