Discussion: Deep Cleaning Schedule/Schedule Adjustment

The Ypsilanti Community Schools' Board of Education will discuss the superintendent's decision to address the physical and mental health of our students and staff with deep cleaning and school closures that will result in a calendar adjustment.

Dr. Zachery-Ross:

Dear YCS Families,

Here at YCS, we consider the health, safety, and wellbeing of our students and staff our top priorities. As we have been in communication with our staff about the importance of Compassion Resilience this year, two central themes have been at the top of everyone's mind, physical and mental wellness.

We all know that we are in a continuous learning process regarding the mitigation of COVID-19, and as we enter the fall flu season, we are being careful to ensure that we are all using the recommended steps to keep everyone safe. Our outstanding custodial and maintenance staff have been going above and beyond to ensure our buildings are in the best condition possible.

In addition, we realize that staff have been stepping up to fill in the gaps due to staffing shortages in all areas in the district and we are incredibly grateful for their collaboration. This has resulted in our amazing YCS staff experiencing an unprecedented level of fatigue. We are holding Compassion Resilience Circles in every building. We are utilizing the book Onward by Elena Aguilar with our administrators to intentionally address our staff and students' social, emotional needs.

As a result of careful review and consideration of the physical and mental health needs, the District Administration has chosen to address this situation by taking the following proactive measures. On Monday, November 22, and Tuesday, November 23, 2021, all YCS School buildings will be closed for DEEP CLEANING in a phased approach that will continue through Winter Break. Staff who are not working for this special project and not providing services to our partner districts will not be required to work. We chose these days as we were previously scheduled to be closed from November 24th to 26th and hope that this will be less intrusive to our families. We acknowledge that this change in the calendar may cause some families inconvenience and we apologize in advance. Yet, as we consider the physical and mental health and safety of all of our students and staff, we believe this pause is necessary at this critical time, which will allow us to come back from Thanksgiving break strong.

As you know, we at YCS take great pride in being responsive to the needs of our students, families, and staff. As a result, we believe in the "both/and" approach to responding when working "with" our students, staff, families, and the community. As a district, we work hard to provide our students with as many learning opportunities, additional learning time, and educational experiences that we can support.

Because each student has a technology device and most students have access to the internet, we will provide our students with the tools they need to do independent work during these two days, if so desired. Our staff will work with our students to ensure that they have what they need to be successful during these two days.

In addition, our students will receive a (2 day) food parcel provided to them on Friday, November 19, 2021, at the end of the school day. Please know that we take the honor and responsibility of educating your students very seriously. It takes all of us working together to ensure healthy learning environments.

Trustee Goodrich: Thank you, Dr. Zachery-Ross for your thoughtfulness. I agree with your position.

Vice President Lee: Thank you, Dr. Zachery-Ross. Are there any facilities to help with child care on 11/22 and 11/23?

Dr. Zachery-Ross: Not yet but usually the Community steps up at this point.

Trustee Schindler: It is the right choice. I really appreciate the thoughtfulness because both are important.

Trustee Gainsley: It is a difficult decision. Neighboring districts have shut down due to illness. It is good to be proactive. Thank you for letting parents know early and for the good communication. Maybe we could host a vaccination clinic on one of those days. Dr. Zachery-Ross: Thank you for the clinic idea.

Trustee Townsend: I would like to express my gratitude because it wasn't an easy decision to make and think it is necessary. This may be the new normal and it is good to be proactive. It is a good opportunity for the village to step up and help so if there are any leased day cares, maybe they can reach out to YCS and let us know of availability. Maybe we as a district can let them know how to reach out because there are a lot of smaller day cares out there that many not be aware of the technology so they can partner with the district. Our educators have been working hard and it is necessary for them to get a break.

Dr. Zachery-Ross: We will reachout to the community with Ms. Haines' number and email for people to be in touch. Thank you for that suggestion, Trustee Townsend. Just a reminder that is your child is sick, stay at home. If staff is sick, stay at home. Please don't push through.

Trustee Fields: We can let people know about Child care network if they need child care for those days. I ditto everything that has already been said. This is also a good time to take care of our mental health. We can use this time to get prepared for what is next. Dr. Zachery-Ross: We will make sure we have a list that we will communicate widely and work with businesses and parents with the cost of child care. There is still opportunity on the table because we have a little bit of time. We will get those resources as soon as possible starting as early as tomorrow gathering them.

Dr. Hawkins: Echo everything that has already been said. We started earlier this year in August so this recommendation is one that is much needed and welcomed. We know it may be an inconvenience to our families but the proactive measures are important. We need to attend to mental and physical health. Making sure there is food during this time. We all need a break. It is a good time to pause and use this time to recharge and reflect.

Trustee Townsend: Thank you for all your support. I got my invitation to the white coat ceremony and felt official. I'm very happy to be in this role. I want to thank again the entire board and administration team for being so welcoming. I want to give a special thank you to Julie Haines. She has been awesome. I talk to her more than I talk to my husband right now. This position is a lot of work but I am honored to be in this seat.

Dr. Hawkins: It is a privilege and an honor to have a 7 member board again. It is Trustee Townsend's first official board meeting and we are thrilled to have her here with us. It has been a very busy thirty days but everyone jumped right in to help. We will all be refreshed the next time we see each other because we won't see each other until December.

Trustee Fields: I am excited for the conference and happy to represent YCS. I think it is a beautiful thing. I'm sorry I'm missing the white coat ceremony.

Dr. Zachery-Ross: Thank you for accept my proposal. It takes courage and vulnerability to lead right now so thank you for leading. Thank you for going to the conference and taking the time out of your busy lives to keep learning so we can serve better. We will have a special board meeting on Wednesday, November 10 to discuss the Cognia process just to prepare the board members for their sessions on Monday, November 15th. There was a training session earlier today and since there was going to be a quorum, we wanted to post it for transparency purposes. The White Coat Ceremony is part of the program that Rhonda Germany Ballintyn presented to the board awhile ago about a new pilot program this is starting with 20 4th graders. The students will be in the program all the way up through high school and she is providing all the funding including two teachers and two parapros who will be with these students throughout. They will meet once a month at YIES. The program is taking place at YIES because it is the last elementary school to let out. The White Coat Ceremony is Thursday and the number of people who can come is limited for social distancing. The students will get lab coats like you would get in medical school with their names embroidered on it. There was a parent orientation this past Thursday. We are working hand in hand with U of M to do the research on the program. We will send them your regards. Congratulations to Debra Stevens and Carla Whitsett. Great examples of the outstanding staff we have here at YCS. EMU home game award winner is Pedro Betancourt. Congratulations to all our fall athletes, parents, and supports for ending strong. Our fans are there for one thing and that is support our student athletes. The HRAs are here. They are taking over the contact tracing. They are doing antigen testing every day Monday - Friday from 9:00 to 11:00 a.m. They are working with the health department. Once they get their feet under them they will start going to schools and doing health education, safety education. There will also be someone covering the weekends to answer questions so Ms. McCarty doesn't have to spend the weekend answering those questions. They will be able to flex their time to cover that. They will be able to help with our communication and help parents with questions. It will give parents some peace of mind when they have questions.
