

Payroll \$\$- Please remember to get your timesheets into Judi Wills by the due date indicated on the <u>payroll calendar</u>. It is the second column from the right of the linked document. Your building administrator or department director will be able to assist you with the process. Human Resources and the Business Office will be sending out an email with written directions along with a graphic presentation to assist everyone. Basically, we will submit timesheets using the same timelines as last year, but with an electronic process tied in for remote and online hourly staff. An official communication will be sent out the week of September 14, 2020.

District provided professional development **(DPPD)** is very different this year. It is important that we all sign in and sign out using the links provided in the chat box during each event. It is crucial that you sign in and out only once to allow for accurate data that will be uploaded to the Michigan Online Educator Certification System **(MOECS)**. Safe Schools Modules - Thank you to all staff members who have successfully completed the modules. I am so happy to say that we were able to release the modules in late July again this year. Many of you were able to take advantage of this early release. There were two half days allowed this year for completion of the modules on August 25 and 26, 2020. Please complete any remaining <u>safe schools modules</u> immediately. The modules were due on September 2, 2020 and are mandatory. Human Resources will contact staff members individually to troubleshoot any issues.

On September 2, 2020 the District provided the **Title IX** mandatory training for all staff. This training is required for any person who is hired and compensated by the District. It was a pleasure to engage in learning with many of you during your Professional Learning Days. The learning facilitated on August 26, 2020 was directly connected to ensuring we have a strong Instructional Infrastructure and to our YCS Priority Goal #1: To substantially improve the quality of teaching and learning and thereby significantly advance the learning for all YCS students.

Building a Guaranteed and Viable Curriculum: Building the Why.

We hope that each of you walked away from that learning with a better understanding of the rationale and components of a Guaranteed & Viable Curriculum. Additionally, it was our intention to bring your attention to essential standards both their importance and how we might identify them. Finally, we asked you to make connections between a Guaranteed & Viable Curriculum and how it drives the work of teacher teams. We left you with the following to consider before we come together next time:

- 1.Are all students learning the same content regardless of teacher or school?
- 2.Are all students assessed using the same criteria for proficiency?
- 3.Are all students provided with extra time to learn and demonstrate proficiency in essential standards?
- 4. Are all students given opportunities for extended learning when they have demonstrated proficiency inside of essential learning targets?
- 5.Is this the work/focus of our teams?

Technology

Tech Support - We continue to see a large volume of tech support requests, please continue to use the ticket system (helps us track issues and prioritize our requests), or if you are unable to use the <u>ticketing system</u>, please use <u>techsupport@ycschools.us</u>. Please do not send tech help requests to <u>techdirector@ycschools.us</u>; this email is primarily used for mass communications only.

Device shortage - We have ordered several student devices to provide for our students in the district but there are expected delays. We have received a large amount of devices back that were either damaged or have manufactured issues. Please let our families know that we will replace them as soon as our orders come in.

Online Directory - We are working on safely publishing an online directory that will consolidate information and navigation of the district's online courses for our families. The intent for this directory is a way for our families to easily navigate and find the online courses for their students. We hope to have this published early next week on the website.

Wireless - We are working on a solution to allow for personal devices to access our network. Please keep in mind that if you use a personal device on a school network which is considered public domain, your device could be subject to a state audit under the Freedom of Information Act. Another consideration is that we content filter all network traffic; so your device would be subject to the same requirement meaning you'd have to load a certificate on your personal device to access our network. And last, if this plan is approved by the district leadership, we cannot provide any technical support for your personal device. I'll release more information once we know our solution is viable and accessible. More to follow in the coming weeks, we just ask for a little patience.

Facilities

Welcome Back Staff! The YCS Facilities Department is committed to the health and safety of our students and staff and the greater Grizzly Community. Our team has been hard at work preparing our facilities for a safe return to school. The <u>YCS Pandemic Response Cleaning Protocol</u> linked here is based on the <u>CDC recommendations</u> and the <u>MI Safe Schools: Michigan's 2020-2021 Return to School Road Map.</u>



All classrooms have been furnished to support social distancing for the instructional day. Only essential furniture was placed in classrooms, socially distanced and all faced in the same direction. Staff have been afforded Ready To Use (RTU) disinfectant wipes for the purpose of disinfecting their personal work space, desk and other personal belongings. The RTU wipes do not require gloves or other PPE for use. However, gloves, masks and face shields are available upon request. Masks must be worn by all students and staff at all times while inside our YCS facilities.

Covid-19 signage was also placed throughout each of our face to face buildings. This signage is intended to communicate expectations set for entry into the facility, as well as reminders throughout the building regarding facial coverings, social distancing and good hygiene. Hand washing directions and reminders were installed at sinks and in bathrooms. All classrooms have numbered circles at the perimeter of the classroom to support line formation and social distancing during lunch time custodial services. At Estabrook, social distancing dots with directional arrows were placed in the hallways to educate and scaffold social distancing and movement throughout the building for our younger students.

We welcome you back to school whether you are supporting face to face instruction, remote learning or virtual learning. Your dedication to our students and our community is felt each day you serve. Thank you for all you do and please reach out to our department with any requests you may have related to your safety and comfort and the safety and comfort of others. I-RIP for TK-5 - We are responsible for completing an I-RIP for every qualifying TK-5 student that meets the assessment requirement as soon as you get a Fall 2020 NWEA score for the student. We have 30 days to complete and share with families the I-RIP for qualifying students. - <u>I-RIP Process</u>

CURRICULUM Assessment - <u>Presentation Link</u> (There is a lot in this presentation--I'd recommend reviewing it)

- Requires ECOL for the year end goal for district
- Goals must include assessment that is aligned with state standards and administered to all students K-8
- Proficiency or growth on Reading and Math, Pre (first 9 weeks) and post
- MDE assessment providers (4 have been chosen)
- Internet provided, CAD
- Immediate feedback, nationally normed, multiple measures of growth, etc.
- Approval of providers, not specific assessment
- RTL one benchmark provided at no cost Smarter Balanced through DRC, ELA and Math grades 3-8, see Aug 27 Spotlight, more information coming from DRC
- One or more "benchmark assessment that provides prog monitoring and enhanced diagnostics
- Private schools do not receive state aid and therefore should not be held to this legislation, however a definitive answer will be coming soon.
- Local benchmark assessments are exempt from aggregate reporting but have different reporting obligations
- Provide to parents within 30 days after test admin
- Attempt to deliver assessments that have been previously used (longitudinal data)
- Determine loss of learning due to pandemic

Accountability - Accountability Presentation Link

- Worried about lack of data and what this means for students, federal accountability expectations were
 waived for 19-20 school year, no identification of schools, including exiting schools, AER is still required
 excluding assessment and accountability civil rights, teacher qualifications and per pupil expenditures
 still required (MDE will complete all reporting, schools just need cover letters), timeline will be shared in
 the coming weeks, after Mischooldata redesign is fully launched. Likely later in the Fall
- Still hoping that legislature will waive A-F grading system that had been planned for this year.
- Preview in late October available
- No index based on 19-20 data.
- Should not expect a waiver on assessments from Feds, so 20-21 index will be run in late Fall/early Winter of 21-22
- Participation is not tied to WIDA in A-F system, and will not be run for 19-20 in index, but will be run for 20-21 including 95% participation rate
- Absenteeism will be run through March 13th of 2020, but not beyond for 19-20 calculation
- Parent dashboard is being updated with non-assessment data

Updates to the General Education Leadership Network (GELN):

• Last Thursday the MDE team met with GELN and the school improvement network. I wanted to share the information and links to the materials and powerpoints in case you are wondering about any of these MDE initiatives.

Literacy -

- 3rd Grade Retention in effect unless we don't test with MSTEP. MDE is re-requesting a waiver for statewide summative assessments. MDE Response to Federal Waiver Denial
- RBG3 law is still intact this year
- 4th grade still required to do IRIPs
- MDE Return to Learn Webinars FAQ coming after all sessions are complete
- Competitive grant from USDOE 5 districts to develop Literacy plans for K-12, \$16 million over 5 years, webinar later this Fall
- Communicate with vendors about how to maintain reliability and validity in an alternate environment

Special Populations -

- ELs Entrance and Exit criteria changes, alternate entrance guidance for online students, auto exit is now in place and active. (3-12 is 4.8, K-2 is 4.8 or higher) K-2 will still need auto exit. Enough students tested last Spring to initiate auto exit, date of 6/30.
- Webinar and other materials for this protocol are available on MDE EL website. Local reading assessment is removed from entrance criteria. K assessment is still lengthy listening and speaking, later writing still 2 phase. K screener will be implemented Fall of '21.
- Temporary guidance is available for ID of ELs online, if in person is available then these guidelines are not applicable. HLS, Phone interview with family, document and begin services if appropriate, ID in MSDS

African American Student Initiative/Equity - Presentation Link

- Phase 1 Free for schools that are CSI, ATI, ACS. The cost is \$100.00 for five online sessions, 2 Cohorts
 Fall and February
- Phase 2 Spring and Fall, going deeper to institutionalized inequity
- Training at all levels from Supt'd Rice to support staff for implicit biases

MICIP - MICIP Mindset Presentation - adding Equity

- Request for data set templates from the field (<u>see folder from today's resources</u>). An additional tool to assess readiness to be on board with data sharing and connectivity to HUB
- "MICIP will be ready when you are" limited launch on October 5 with existing testing partners
- Statewide rollout Jan 4, integrations with CTE and SE will follow
- Deadlines for changes in ASSIST to be ported over to MICIP is passed. You can manually save from ASSIST through September.
- Process and platform guides are in development, as well as a sample plan. Training opportunities for CIFN and GELN on Oct 7 and 16, afternoon of 16th will be a technical training that will be recorded and released after CI Conference on the 20th. All presentations will be available for 30 days after the conference.
- Disregard any messages from ASSIST indicating "your plan is late"
